- Nomination Package -

The Ophea Award of Distinction is presented to one individual who is a **leader in the meaningful advancement of inclusive healthy, active living opportunities for children and youth** in Ontario school communities.

Eligibility requirements include:

- □ The contributions of the recipient's impacts are regional and/or **provincial in scope**
- □ The recipient has **demonstrated excellence** in the areas of advocacy, partnership development, and/or the provision of quality, innovative, inclusive programming
- □ The recipient has made a **long-term contribution** to improving the health and wellbeing of Ontario's children and youth
- □ The recipient of this award is **well known to Ophea** for their **contributions and years of service and support in service student well-being**
- □ The recipient's work/volunteer contributions **impact schools and/or communities** (e.g. educators, public health workers, recreation providers, etc.)

The *Ophea Award of Distinction* is presented in honour of Bing Caswell, a dedicated professional whose thought leadership and commitment led to the advancement of knowledge and understanding in the field of health and physical education.

To officially submit a nomination for the 2023 Ophea Awards, a Nomination Package must be completed and submitted **in full** to Ophea.

The Ophea Awards Nomination Package includes:

- Nomination Form
- Summary of Nominee Eligibility form (a summary of how the nominee meets the award criteria)

* To be considered for an Ophea Award, each item in the Nomination Package must be fully completed.



Nomination Guidelines

- Candidates can be nominated for a maximum of one award annually.
- Nominees who are not selected for a 2023 Ophea Award can be nominated in subsequent years.
- Individuals can only win each Ophea award once.
- Completed Nomination Packages are assessed by the Ophea Board of Directors. Information assessed by the Board will be kept confidential.
- The nominee must be aware of their nomination form and Award winners will be contacted by Ophea prior to being profiled on Ophea.net or in any other communication channels.
